



## Ambassador Agreement & ACH Authorization

*(California Independent Contractor Referral Program)*

**This Agreement** is entered into between **Nestey Enterprise Inc.**, a California corporation, with offices at 4205 Cincinnati Ave Suite 300A, Rocklin, CA 95765, and the undersigned Ambassador ("Ambassador"), effective as of the date signed below.

---

### 1. Program Overview

Nestey Enterprise Inc. operates an Ambassador Referral Program ("Program") that compensates individuals and licensed professionals for referring qualified solar customers. Ambassadors are **independent contractors** and not employees of Nestey Enterprise Inc.

---

### 2. Ambassador Types & Eligibility

- **Casual Ambassador:** Any individual over the age of 18 who refers to solar leads to Nestey Enterprise Inc. without holding a professional license. Compensation: **\$0.20 per watt installed and paid in full.**
- **Professional Ambassador:** A licensed professional (e.g., Contractor, Realtor, Insurance Agent, Financial Advisor) approved by Nestey Enterprise Inc. Compensation: **\$0.40 per watt installed and paid in full.**

Nestey Enterprise Inc. reserves the right to verify licensing, reject referrals, or terminate participation at any time.

---

### 3. Referral Rules

- Referrals must be submitted using the approved Nestey process (including Ambassador code or link).
  - Ambassadors may not provide quotes, negotiate contracts, or represent themselves as an agent or employee of Nestey Enterprise Inc.
  - All marketing must comply with CPUC and Nestey guidelines.
  - Referrals must result in a signed contract, completed installation, and full customer payment to qualify for payout.

### 4. Payment Terms

- Payouts are calculated on **actual installed wattage** at the applicable tier rate.
  - Payment is made via ACH within **5 business days** after job completion and payment from the customer.
  - Cancellations, downsizing, or non-payment will reduce or eliminate payout accordingly.
  - Rates may be changed with **30 days' written notice**.
- 

### 5. Independent Contractor Status

Ambassador is an independent contractor and is responsible for their own taxes, insurance, and expenses. Nothing in this Agreement creates an employment, partnership, or joint venture relationship.

---

### 6. Confidentiality

Ambassador agrees not to disclose any confidential business information obtained through participation in the Program.

---

## 7. Termination

Either party may terminate this Agreement at any time with written notice. Outstanding qualified referrals will be paid according to program terms.

---

## 8. Governing Law

This Agreement is governed by the laws of the State of California. Any disputes will be resolved via binding arbitration in Sacramento County, California.


